

Those who already have donation envelopes and join the Pre-Authorized Giving plan can simply put "P.A.G." on the front of their envelope and place it in the collection plate each week.


For those who do not have envelopes and wish to use the P.A.G. plan and want to place an envelope in the collection plate, boxes of envelopes are available from the parish office during business hours.

WHAT IS THE PRE-AUTHORIZED GIVING PLAN?

The pastoral work of St. John's and ShareLife is made possible through the generosity and giving hearts of our parishioners. In response to changing lifestyles and demands on time and energy, the Archdiocese of Toronto has established a Pre-Authorized Giving plan (P.A.G.) to assist you in your support of the mission of the church at the parish and diocesan levels.

HOW DOES IT WORK?

Your offering will be withdrawn from your account on or about the 20th of the month and deposited into the Parish account.

WHO LOOKS AFTER THE PLAN?

The Office of Stewardship and Development of the Archdiocese of Toronto administers the Pre-Authorized Giving plan for parishes in the Archdiocese.

HOW DO I ENROLL?

- ◆ Decide the amount of your monthly gift to the parish.
- ◆ Fill out the form on the other side of this brochure and attach a void cheque in the space provided.
- ◆ Detach the form along the dotted line and place it in the collection plate or mail it to the parish office. Attention: Parish Secretary, 432 Ontario St. Newmarket, Ontario, L3Y 2K4.

WHY SHOULD I PARTICIPATE?

The Pre-authorized giving programme is beneficial for both you as a donor and the parish as a recipient. Through this programme, you as a donor do not need to remember to bring your donation and envelope each week. And when you are away, you are still able to continue to support your parish. For the parish, we can depend upon a reliable and consistent flow of contributions which is invaluable as we budget for the administration and pastoral work. There is also far less paperwork involved for the accounting office.

HOW DO I CANCEL IF I CHANGE MY MIND?

You may stop P.A.G. at any time by simply writing a letter with 30 days notice to St. John Chrysostom Parish. If you would prefer to use a standardized cancellation form instead of writing a letter and the parish does not have one on hand (or for more information on your right to cancel your P.A.G. agreement) please contact your financial institution or visit www.cdnpay.ca. You have certain recourse rights if any debit does not comply with this agreement. For example, you have the right to receive reimbursement for any debit that is not authorized or is not consistent with this P.A.G. agreement.
