Notes:

It is highly recommended that all regular burials be enclosed in a cement vault or crypt to prevent damage from adjacent burials. Double Depth burials require the use of a vault or crypt. Vaults or crypts are purchased through the funeral home and include grave preparation services.

Burials in plots provided with a monument foundation shall be head to the foundation.

FOR YOUR INFORMATION

- 1. When a person has died, the division Registrar will issue a Burial Permit showing that the death was registered. This permit must be surrendered to the Cemetery Board **prior to interment.**
- 2. Proper identification of the burial site and precise instructions should be given to the Cemetery Board prior to interment, as the Board cannot be held responsible for any errors resulting from incorrect instructions or lack of information.
- 3. Except in special circumstances, the Cemetery Board shall be notified at least 48 hours prior to interment to allow sufficient time to prepare the grave site for funerals.
- 4. A maximum of two regular interment may be made in any one adult grave site. Special arrangements can be made with the Cemetery Board for additional cremation burials in a full-size adult plot if required. No plot may contain more than 4 burials total.
- 5. All outstanding amounts for plot cost, care and maintenance, and other cemetery charges <u>must be paid in full</u> prior to any interment in the same plot.
- 6. The person authorizing the purchase of a plot shall be responsible for all charges incurred.
- 7. Please note that plots in Section J and G will be sold in numbered sequence only starting with either the north or south end of Row 1.
- 8. For disinterments, if the original burial did not include an outer container, one must be purchased through the authorizing Funeral Home.
